(collectively, the "CAEN ELS SwFw")

The use and distribution of this CAEN ELS SwFw (or any work based on the CAEN ELS SwFw) implies the acceptance of the terms and conditions set out below.

The Licensor - hereinafter Licensee - hereby authorizes you to use this CAEN ELS SwFw within the context of the following licensing conditions:

**1. License Uses and Restrictions**

CAEN ELS SwFw applications, documentation, and local computer files installed or utilized by the installer application are owned by CAEN ELS, and are licensed to you on a worldwide (except as limited below), non-exclusive, non-sublicensable basis as per terms and conditions set forth herein. This CAEN ELS SwFw License defines the legal use of the CAEN ELS SwFw, all updates, revisions, substitutions, and any copies of the CAEN ELS SwFw made by or for you. All rights not expressly granted to you are reserved to CAEN ELS or to their respective owners.

CAEN ELS grants you a limited non-exclusive license to use this CAEN ELS SwFw, subject to the following restrictions:

- 1) The origin of this CAEN ELS SwFw must not be misrepresented; you must not claim that you wrote the original CAEN ELS SwFw;
- 2) You must not alter the CAEN ELS SwFw, user license or installer in any way;
- 3) This notice may not be removed or altered from any distribution;
- 4) You may not resell or charge for the CAEN ELS SwFw;
- 5) You may not reverse-engineer, decompile, disassemble, derive the source code of or modify [or create derivative work from] the CAEN ELS SwFw;
- 6) You must not use CAEN ELS SwFw, or allow others, to engage in any illegal activity;
- 7) You may not claim any sponsorship by, endorsement by, or affiliation with our company;
- 8) You acknowledge that CAEN ELS owns the copyright and all associated intellectual property rights relating to the CAEN ELS SwFw except to the extent that the CAEN ELS SwFw includes identifiable separate components originating from the CAEN ELS SwFw.

**A. YOU MAY:**

- (i) install and personally use the CAEN ELS SwFw and any updates provided by CAEN ELS (in its sole discretion) in an object code form on a personal computer or on board on CAEN ELS' Products owned or controlled by you and may use the CAEN ELS SwFw for your own non-commercial use or benefit. Your license to the CAEN ELS SwFw under this CAEN ELS SwFw License continues until it is terminated by either party. You may terminate the CAEN ELS SwFw License by discontinuing use of all or any of the CAEN ELS SwFw and by destroying all your copies of the applicable CAEN ELS SwFw. This CAEN ELS SwFw License terminates automatically if you violate any term of this CAEN ELS SwFw License, if CAEN ELS publicly posts a written notice of termination on CAEN ELS's web site ([www.caenels.com](http://www.caenels.com)), or if CAEN ELS sends a written notice of termination to you;
- (ii) make a copy of CAEN ELS SwFw only if it is necessary for its use.

**B. YOU MAY NOT:**

- (i) decompile, reverse engineer, disassemble, modify the CAEN ELS SwFw or any portion thereof in order to resell, rent, lease, loan, distribute or create derivative works (as defined by the Italian Copyright Act, 1.22 April 1941, n.633 and following amendments) or improvements (as defined by Italian patent law), without CAEN ELS's prior, express, written permission;

**2. Copyright and Transfer of the CAEN ELS SwFw**

- 1) The Licensee may reproduce the CAEN ELS SwFw, if such reproduction is necessary for the use of the CAEN ELS SwFw. Necessary reproductions include the installation of the CAEN ELS SwFw from the original system disk or from the downloaded installation archive on the mass memory of the hardware, as well as the loading of the CAEN ELS SwFw into the main memory during CAEN ELS SwFw operation;
- 2) Moreover, the Licensee may reproduce the CAEN ELS SwFw for backup purposes. However, only one backup copy of the original system disk or the downloaded installation archive may be created and/or stored. Said copy must be marked as a backup;
- 3) Should a rotational backup of a system's entire data set, including the CAEN ELS SwFw programs, be essential for a fast reactivation of the system following a complete breakdown, Licensee may create backup copies in the quantities absolutely required. The pertinent system disks shall be marked accordingly. These backup copies may be used for archive purposes in connection with data backup only;
- 4) Licensee shall take the necessary steps to prohibit unauthorized access to the CAEN ELS SwFw and its documentation by third parties. Affiliated companies of the Licensee are also regarded as being third parties. The original data media, as well as all backup copies, shall be stored in a secure place, safe from access by unauthorized third parties. The Licensee's employees shall be expressly informed as to their obligations to observe and abide by all contractual conditions specified herein, as well as all provisions of copyright law;
- 5) The Licensee is not authorized,
  - a. with the exception of the reproductions expressly authorized in this agreement, to create other reproductions of the CAEN ELS SwFw or the documentation, either wholly or in part, on the same or on other disks/carrier media; this also includes the output of the program code to a printer;

  - c. without the written express permission of the Licensor, to change, translate, retro- develop, decompile or disassemble the CAEN ELS SwFw, or to create works derived from the CAEN ELS SwFw or documentation, or to reproduce, translate, change or create works derived from the documentation, insofar as this is not absolutely necessary within the context of contractual use;
  - d. to remove copy right endorsements, serial numbers or other features which serve to identify the program, unless the Licensor has provided written authorization;
  - e. to transfer the CAEN ELS SwFw to third parties or to provide access to the CAEN ELS SwFw in any other form. This also applies to reproduction of the CAEN ELS SwFw. - f. to transfer the CAEN ELS SwFw, the documentation or parts thereof to third parties for the purposes of renting or leasing.

This CAEN ELS SwFw License grants you no right, title, or interest in any intellectual property owned or licensed by CAEN ELS, including (but not limited to) the CAEN ELS SwFw and the CAEN ELS trademarks, and creates no relationship between you and CAEN ELS other than that of CAEN ELS to licensee.

You agree that you will use the CAEN ELS SwFw, and any data accessed through the CAEN ELS SwFw, for your own personal non-commercial use only. You agree not to assign, copy, transfer, or transmit CAEN ELS SwFw. Your license to use the CAEN ELS SwFw will terminate if you violate these restrictions. If your license terminates, you agree to cease any and all use of the CAEN ELS SwFw. All rights in any third-party data, any third-party CAEN ELS SwFw, and any third-party data servers, including all ownership rights are reserved and remain with the respective third parties. ### 10. Controlling Law

Any dispute arising out of or in connection with this Agreement shall be referred to and finally resolved by Arbitration under the provisions of Italian Law (c.p.c. art 816 and following) by one Arbitrator. The Arbitrator shall be nominated from Chairman of the Court of Milan.

The place of Arbitration shall be Milan, Italy and the language shall be English.

### 11. Precedence

This CAEN ELS SwFw License constitutes the entire understanding between the parties respecting use of the CAEN ELS SwFw, superseding all prior agreements between you and CAEN ELS. In the event of any conflict between the terms and conditions of this CAEN ELS SwFw License, the terms and conditions of this CAEN ELS SwFw License will prevail.

### 12. Validity

These CAEN ELS SwFw License are valid from December 19<sup>th</sup>, 2025 and shall be operating for all orders that have been executed, during its validity.
